General provisons

The dog show is organized according to the dog show rules of the FCI and ČMKU. Only dogs entered in FCI-accepted stud books are allowed to take part at the show. Dogs which have reached the age required for entering the desired class on the show day at the latest. Division into classes is according by the FCI Show Regulation and is described in the registration form. In case no copy of a certificate approving the fulfilment of the conditions for entering working class or champion class is attached to the entry form, the dog will be put into open class. The organizer of the show is not responsible for any damages caused by the dog or by the exhibitor neither for death nor for loss of the dog. Dogs with cropped ears are not allowed into the show grounds and will not be judged. Changes in exterior of a dog performed by means of excessive use of lacquer, powder, hair tinting and basic trimming connected with a long-time tying-up of the dog on a table are forbidden on the show. The violation of these rules can lead to disqualification of the dog. The exhibitors are obliged to abide with the provisions of the FCI Show Regulations, of these propositions and the instructions of the Show Committee, to which they bind themselves by submitting the entry form. They are also obliged to maintain the exhibition area clean. In case the show does not take place for objective reasons, the fees would be used for covering the show preparation expenses. It is forbidden to bring puppies for the purpose of sale to the show. The organizer does not accept any responsibility for undelivered applications. Documents submitted after the 2nd entry deadline will not be taken into consideration.

Veterinary provisions

- All participating dogs must be clinically healthy.
- Dogs do not need a certificate of clinical health examination anymore.
- Dogs that have not been checked by veterinary check-in on entry can not participate at the show.
- Dogs must have a passport for small animals (EU pet passport) or a vaccination passport containing a record showing that the dog was vaccinated against rabies 21 days to 1 year before the show, and is in immunity against canine distemper, parvovirus and leptospirosis. Dogs coming from EU member states and from third countries must have a valid EU pet passport and must fulfil the conditions laid down by the EU Regulation 998/2003 of 26/5/2003
- The owners should take measures ensuring that mutual attacks among animals or injuring people is prevented during the show.

Instructions for filling-in entry forms

Entry forms should be filled out using a typewriter or in block letters. For each dog, a separate entry form should be filled out. Illegible applications will not be accepted. The discount for the second and additional dogs may be applied only if the name of the owner is the same as for the first dog. Any change in these conditions, e.g. addition of joint ownership, will be considered to be a new entry at full cost. The organizer does not accept any responsibility for an incorrectly filled-

in entry forms. A copy of the pedigree must be attached to each application form. In the case of an imported dog, the abbreviation of the original studbook and the original registration number must be written in the entry form.

Proof of payment must be attached to the entry form, otherwise the application will not be accepted. A dog can only be entered into one class. Moving dogs between classes is not possible after the deadline. Accepting of the entry form will be confirmed 10 days before the show. If the exhibitor does not receive the entry confirmation by above-mentioned time, it is possible to check on www.pannoniaklub.cz in the list of exhibitors, whether the application was accepted. Protest

A protest against any decision made by the judge is not admissible. A protest can be submitted for formal reasons such as violation of show regulation provisions and proposition provisions. The protest must be submitted in write form, against a deposit of 45 Euro, during the course of the show. If the protest is found to be unjustified, this deposit will be forfeited to the organizer of the show.
